Who we are

Fiberguide Industries respects your right to privacy and will process personal information you provide only in accordance with the General Data Protection Regulation 2018, the Privacy and Electronic Communications (EC Directive) Regulations 2003 and other applicable privacy laws.

The information collected and how it is used

Fiberguide Industries will not collect any information about individuals, except where it is specifically and knowingly provided by them.
